LEGAL ADVOCACY IN ACTION!

The Supreme Court decides what cases it will hear, and AAUW will continue to report on those we have been following. Here is an update on two of those cases:

Rizo v. Yovino:

This case is about the discriminatory practice of using prior salary alone to determine current wages under the Equal Pay Act of 1963. We should hear shortly whether the Supreme Court will take this case.

Andersen v. Planned Parenthood of Kansas and Mid-Missouri:

This case considers whether a state should be able to bar an eligible health-care provider - which also provides a full range of reproductive health-care services - from the Medicaid program and whether or not those contract terminations can be challenged. The Supreme Court declined to hear this case, leaving the lower court decision in place. That decision ruled that Medicaid recipients can challenge the state's action.

STATE AND NATIONAL AAUW NEWS

The U.S. Department of Education is attempting to erode the Title IX protections from sexual harassment and assault by announcing in November 2018 a Notice of Proposed Rulemaking (NPRM). The November 2018 NPRM would weaken Title IX's protections by narrowing the definitions of sexual harassment to potentially exclude much of the abuse students experience and changing when schools must respond to reports of sexual harassment and violence. The rule would install processes that would make it more difficult for students to lodge a complaint and receive support when they experience sexual harassment or assault. Title IX protects all students from discrimination, from kindergarten through college.

AAUW joined 123 organizations and 231 individuals in requesting that the Department of Education extend the comment period for the NPRM to allow time for meaningful public participation. The comment period is currently 60 days. AAUW is seeking an additional 60 days.

The Affordable Care Act - from AAUW Washington Update 12-21-18

In December, the U.S. District Court for the Northern District of Texas ruled in favor of a group of attorneys general who argued that the Affordable Care Act is unconstitutional. It is assumed that the ruling will be appealed and the ACA is likely to remain in place while it is being appealed. AAUW is committed to the ACA as repealing it would prevent access to women's health care.
