# **State's law requiring insurers to provide abortion in jeopardy**

As American women consider action to ensure reproductive health rights in 2020, it is useful to recall that in the 17th and 18th Centuries pregnancy termination was legal under common law before "quickening" (fetal movement) that occurs approximately 16 weeks after conception.

After 1850, the crusade in the U.S. against voluntary pregnancy termination stepped up. According to Lauren McIver Thompson (author of "Battle for Birth Control ...") physicians, known for irregular practice and lack of training, in order to "establish their place as respected members of society" argued about the "rights of the unborn" – sound familiar? (New York Times, December 15, 2019).

By 1900, in accord with the Comstock Act of 1873, most states had passed laws restricting termination and contraception. As a consequence, by the 1930s one report estimated that 681,000 abortions led to 8,000 to 10,000 maternal deaths.

It took a decision by the Supreme Court in 1973 to change the numbers, but the struggle continues. On Friday, Jan. 24, at the March for Life rally, President Trump threatened to take away California's federal funding in accord with the Weldon Amendment because of California law that ensures private insurers provide abortion and contraception coverage.

The U.S. Department of Health and Human Services gave the state 30 days to lift the regulation, saying that the state is not compliant with the amendment. Note that four years ago federal opinion confirmed California's compliance to not discriminate against a health-care facility.

Yet, Kevin McCarthy (R-Bakersfield) on Feb. 21, emailed support for health care entities that don't want to supply equal legal health services to all.

After the Feb. 4 State of the Union speech, there is no doubt women must continue to advocate for reproductive health rights – especially for black and Native American women, who have far higher pregnancy-related mortality rates than white women.

Of 15 policies suggested by the National Partnership for Women, the most important is access to all forms of abortion care and contraception regardless of where you live.

Lastly, keep track of the U.S. Senate vote on two bills at the end of February: 1) to institute a 20-week abortion ban and 2) to require medical care be delivered to infants that survive abortions, a misleading bill given that infanticide is already a crime.

### Original ruling on the Aileen Rizo case is reinstated

Here's an update on the Aileen Rizo case that Mid-Pen Branch has taken an active interest in:

Aileen Rizo sued the Fresno County Department of Education when she learned in 2012 that a man in the same position was paid at least \$13,000 more because of his previous earnings.

AAUW Legal Advocacy Fund supported Rizo through this case. It was ruled in her favor but the U.S. Supreme Court set the decision aside because the author of the decision died before it was issued.

A Federal Appeals Court reinstated the original ruling at the end of February. The ruling states that employers may not rely on employees' past salaries to pay women less than men. Fresno County may appeal this ruling again to the Supreme Court.

# How did women's issues fare in legislature?

January 2019 brought a new governor to California.

While the previous governor, Jerry Brown, was overall supportive of many of AAUW California priorities, it is expected that Gov. Gavin Newsom has an even greater appreciation for our priorities and values. It doesn't hurt that the First Partner, Jennifer Siebel Newsom, a documentary filmmaker, is a huge advocate for our issues and has considerable influence.

The legislature continues to have an interest in questioning the status quo and moving the needle on issues including the gender pay gap, sexual harassment, employment discrimination, Title IX, family leave, childcare, and education.

However, many issues were overshadowed by a few bills that seemed to take the oxygen out of the room and took up considerable time and attention. While unrelated, they still affected the AAUW California agenda because of the focus on them.

There were major fights over legislation to limit medical exemptions for vaccines, regulation of internet privacy, and pharmaceutical price controls. Also notable was a significant battle over the codification of case law to clearly delineate which workers are employees versus independent contractors, a critical issue for the "gig" economy and those who work in it.

With the 2018-19 legislative session finally at an end, members of the AAUW California Public Policy Committee, along with our Legislative Advocate Shannon Smith-Crowley, are proud to report that 12 of our AAUW-supported bills were signed into law.

Some of our bills, including paid family leave and elimination of the sales tax on menstrual products and diapers, have been dealt with by the budget process, rendering the bills unnecessary.

And, of course, while AAUW scored significant wins, there were some losses that will require attention during the next legislative year.

Three of our bills became two-year bills that may be considered in the 2020

legislative year. These included two of our major bills. The first, SB 171, would have required payroll data to be broken down by gender, race, ethnicity, and job category, and reported to state agencies. The reports would enable state agencies to identify patterns of wage disparities, allowing enforcement of California's equal pay laws.

The second bill, SB 493, would have implemented a process for higher education institutions to prevent, respond and investigate sexual harassment claims. In addition to procedural protections, the bill would have required training of employees engaged in the grievance procedures on trauma-informed best practices and training on implicit bias.

A third bill, AB 500, which would have provided maternity leave to California teachers and school employees, was passed, but then vetoed by the governor.
